PRESIDENT'S REPORT:

President Stott apologized for the office heat problem, and stated the system is old, and outdated, and it is difficult to get parts for repairs. He stated they will be purchasing a new heating system, and at this point they have one quote of under \$10,000.00. They will save \$100.00 by lowering the service plan price. Blackwood Fire Company will get (3) more bids.

He stated all the paperwork has been completed for the bond insurance, and has been submitted. He does not have a payment date at this time. As far as the Camden County Prosecutor is concerned,

Blackwood Fire Company is the victim, and they have not asked for any input from Blackwood Fire Company.

At the October Blackwood Fire Company meeting they voted to change the Bi-Laws for member percentages. In active firefighters now go off of a duty crew scale, and if you have questions you should speak to the Chief.

The contract for the lease for 2024 will be \$72,500.00 per year, which will be \$12,083.33 for 6 bimonthly payments. The Board will pay all the insurance. Also, the Board will now be paying \$20,000.00 for the stipend duty crews. He wanted to know if the Board has planned for the same moving forward in the 2024 budget.

He asked if there were any changes to LOSAP in 2024, and Commissioner J. Vannoni stated there doesn't appear to be any at this time.

Commissioner J. Vannoni added that no decision has been made on the \$20,000.00 stipend for the duty crews.

Commissioner Jones added that no one form the operation side of things has come to any of our budget meetings. They have been told at several Blackwood Fire Company meetings of the Boards budget meetings. We can't budget for what we think.

Commissioner added we did not receive a Capatins report or a FAM report.
