COMMISSIONER REPORTS:

Commissioner McCann reported the Board had discussed LOSAP, and under old business we will pass a resolution confirming the payment for 2023.

Commissioner Cristella reported the old gear racks from BCR were placed on Gov Deals, and once the bid period is over, they will be sold, for approximately \$1200.00, and a bill of sale will be created as well as a removal from inventory resolution.

Commissioner Jones reported that under old business, a resolution for removal from inventory for 848, will be approved, as it has been sold.

Squad 88 was involved in a minor incident with the gate at Autum Ridge, Captain Procopio is in the process of getting quotes for the repair. FF O'Connor completed FF2. On March 4th Chief Georgio will be in FD # 6 to make a presentation on the initial merger of Fire District # 4 and District # 6 in Cherry Hill. It will be a

question-and-answer presentation. It will be just District # 4 and District # 6, on March 4th at 7:00 PM.

Per Solicitor Carlamere, it does not have to be advertised, since it is a question-and answer session.

In the future, maybe April, we will be looking for a joint meeting between the (2) districts, District # 4 and District # 6.

Commissioner D. Vannoni asked if this will involve our shared service agreement, Squad 88 with District # 2?

Commissioner J, Vannoni said they were told upfront, Squad 88 and our shared service agreement with District #2 will remain, that is a deal breaker.

Commissioner D. Vannoni brought up the subject of having 2 shared service agreements, one with District # 2 and one with District # 5, which he feels will make things more complicated. Commissioner J. Vannoni stated Squad 88 is not going anywhere, but the other, with District # 5 has been brought up, and discussed. Nothing has been decided.

He went on to tell Commissioner McCann, that Chris Brown will be in touch with him to get some financial information.

Commissioner McCann acknowledged he knew you gave him his contact information, but he has not reached out asking to meet.

Commissioner J. Vannoni said there is a change of uniform request out there for patches. The purpose is to make everyone look the same.

Commissioner D. Vannoni asked if we are now one district?

Commissioner J. Vannoni said we are not.

Commissioner D. Vannoni said he feels a though our employees should wear District # 4 on their sleeve, since we are not one fire district. He added he will be voting no.

There was a discussion on who will pay for it, at a cost of \$400.00. Since the change was not mandated by the district, the employees should pay for them, according to the contract. IAFF President Kemery said the contract also says the Board can also pay for them if they so choose. He added this is a morale issue, and said both districts' logos are on the patch.

Motion by Commissioner Jones, second by Commissioner Cristella to approve the new patches, with the stipulation they are approved by District # 2. All in favor, (4) yes, (1) nay. Motion carries.

Commissioner McCann stated at the Workshop meeting, Blackwood Fire Company brought in a representative from a Solar Company, who made a presentation to the Board.
