# **CAPTAIN'S REPORT**

Captain Reiss stated Commissioner Grady covered the leave time. He said staffing is in good shape, and Engine 88 is also good. He thanked Commissioner McCann for all his work on the new Engine 88 purchase.

Captain Reiss reminded the Board that there are outstanding policies and procedures that need to be addressed.

He stated that he has asked several times when the OPS Meeting were going to resume, but has gotten no response. He stated that if the COVID-19 crisis happens again, a better plan must be implemented, and the Boards need to take action now to get that plan in place.
